

Subject: Revised GULF AIR Excess Baggage Rates & Procedures effective June 2010.

GF Baggage charges in excess of free baggage allowance (applicable for sales/travel commencing on/after 01 June 2010).

New excess baggage rates as of June 1st 2010

The new excess baggage rates are applicable to all Gulf Air *operated* flights only.

These rates are *not* applicable for:

- Codeshare flights operated by partner airlines (where the operating carrier determines the applicable rates)
- Interline itineraries with other airline(s) in combination with Gulf Air (where standard IATA excess baggage rates will apply)
- The Piece Concept baggage (to/from USA/Canada routes)

This is a ZONAL based system on flights to and from Bahrain and where applicable, a combination of zones for 6th freedom traffic.

Example:

Flying from London to Delhi with 7 kgs of excess baggage would cost - USD15 (Zone4) + USD7 (Zone3) = USD22 per kilo, times 7 kgs = USD154 total.

Note: The above excess baggage rates in USD should be converted to the local selling currency using the Banker’s Selling Rate (BSR).

Baggage in excess of the free baggage allowance and subject to the weights/measurements applicable to the free allowance, will be accepted for transportation subject to the availability of space on the aircraft upon payment of the calculated excess baggage amount.

Please also note:

- For handling purposes any bag/item which exceeds 32 kgs (70 lbs) shall not be carried as accompanied baggage.
